ORDER: The Court, upon review of the parties' Proposed Settlement Agreement and Notice of Proposed Settlement and Fairness Hearing, notes that the current Rule 23(b)(3) class definition, as defined in the Court's April 29, 2019 Order, excludes a class of plaintiffs that the parties had intended to cover as part of their settlement agreement. Specifically, the definition excludes former PCTs and SPCTs who were employed in the NYPD Communications Section between November 6, 2010, the filing date of the instant action, and October 23, 2018, the date of settlement. Therefore, pursuant to Fed. R. Civ. P. 23(c)(1), the Court amends the class definition as follows:

Section 1981 Rule 23(b)(3) class: All individuals who are currently employed, or have been employed between November 6, 2010 and October 23, 2018, by the City of New York as Police Communications Technicians ("PCTs") or Supervisor Police Communications Technicians ("SPCTs") in the NYPD Communications Section.

The Court finds that this amended class definition satisfies all of the requirements of Fed. R. Civ. P 23(a) and 23(b)(3), for the same reasons articulated in its April 29, 2019 Order. (See April 29, 2019 Memorandum & Order, Dkt. 202, 9-15, 17-21.) Ordered by Judge Pamela K. Chen on 5/15/2019. (Brodziak, Maya)
